RE: Promotion to FEI Level 1 of national eventing officials

Dear National Federation,

The officials play a crucial role in equestrian sports, ensuring fairness, accuracy, and adherence to rules and standards. They are essential for maintaining integrity, while also contributing to the growth and development of riders and the sport itself.

FEI introduced a new education system for eventing officials, effective from 1.1.2023. The document (attached to the email) sets the pathway for promotion, statute maintenance and demotion of the FEI officials.

The FEI Eventing rules provide a transitional period until the end of 2024 in which national eventing officials can take part in FEI events (Endurance Rules Art. 513).

The FEI Education system allows national eventing judges, stewards and technical delegates to be promoted to Level 1 only with online education, the candidates for course designers still have to attend in-person course.
